Regular Conformation Classes:

Puppies: 3-6 mo, 6-9 mo, 9-12 mo

Adults: 12-18 mo, Novice, Bred by Exhibitor & Open

Regular classes are open to all pure-bred Salukis except champions.

Professional handlers may only handle dogs owned or co-owned by them.

Veterans 7-9, Veterans 9-11, Veterans 11 & older, Coursing
Champion.**

Special attraction classes will be divided by sex. These classes are open to all pure-bred Salukis including champions. Coursing entries will need to include certificate of coursing championship. Professional handlers may only handle dogs owned or co-owned by them.

Match judging will begin 1 hour following the conclusion of Saluki judging at the all-breed show. Followed by special attractions, lunch and the regular annual membership meeting.
